**Entrant check-in and tech:** will begin on Saturday morning, 7:00 a.m. at the track. **There will be no class changes after cars are teched unless the car breaks and the break is verified by tech.**

**Autocross:** We plan to use as much of the track as possible. Registration stops at 8:30 a.m. and the driver's meeting will commence; with the first car out immediately following the parade lap.

**Lunch:** will be offered for \$5 per person (pre-registration entrants and guests only)

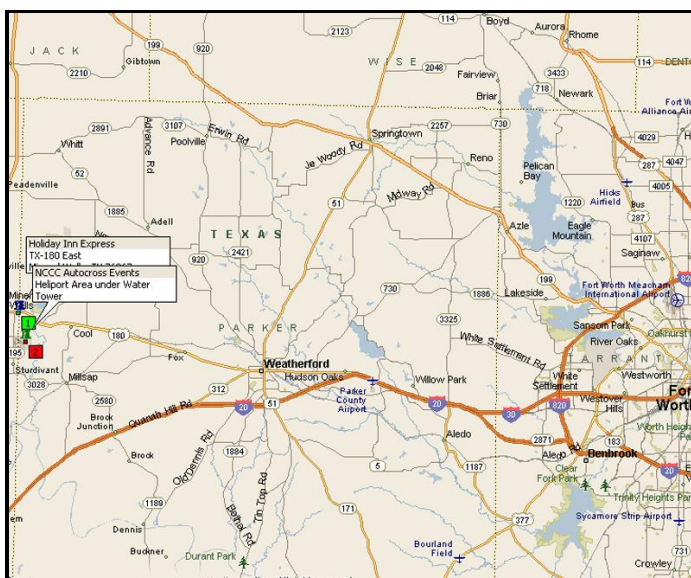
**Note:** the events should be complete before the warmest part of the day so come out and enjoy your Vette.
