Entrant check-in and tech: will begin on Saturday morning, 7:00 a.m. at the track. There will be no class changes after cars are teched unless the car breaks and the break is verified by tech.

Autocross: We plan to use as much of the track as possible. Registration stops at 8:30 a.m. and the driver's meeting will commence; with the first car out immediately following the parade lap.


