Motion to accept April minutes by Terry M; second by Dave G. passed

Dave Heinemann spoke to the committee on issues he feels need to be in place to move NCCC forward:

- Amelia Workman accepting distribution position in place of Larry Higgins
- The distribution responsibilities placed under VP of Membership
- Cutting expenses is one key to NCCC success
  - Going to a 5-year membership card could save \$40,000 annually
- Communicating with entire membership has been successful
- Would not like the 'Webmaster' position go away but remain vacant right now
  - Dave or Walt Jenkins could appoint later
- Look into allowing the R/E's to communicate with their local members

R/E communications should go through the '.org' site not the '.com' site (<u>www.corvettesnccc.org</u>)

Allen Morris reports the Finance Committee meeting:

- 633 tickets for the raffle sold to date; 1080 needed for breakeven and drawing in November
- NCCC budget is \$16,000 in the black but not all bill paid yet; may still end the year okay
- 19,000+ with the influx of many new members recently which has helped
- Charity account will be closed soon and the balance sent to NKF, but not sure when
- IRS is auditing the Charity books since there has been errors in reporting and payments
  - Fines will be assessed and when the audit will be completed is unknown right now
  - o Betty parks continues to work with the attorney and auditors
- NCCC as an organization is in the clear and a \$5,000 refund is held for future tax payments

- Omaha convention looks to be in the black with a possible profit of \$2,300 after everything paid

Larry Pagliaro reported on the results of the newsletter contest

- 18 entries, all were very good, complete, and informative
- Nashville took 1<sup>st</sup>
- 2017 rules will be published by December and Deb Haskel will join the review team

Conventions are finally moving forward:

- 2017 in Bowling Green is on schedule and more info will be out shortly
- 2018 proposal will be presented for New Orleans
- 2019 is still uncertain but possible regions are Indiana or Rocky Mountain

By-Law proposals were voted on to send to governors for their approval:

- #1 Adding Convention Treasurer to Finance Committee passed unanimously
- #2 Adding Director of IT and dropping Webmaster from appointed officers passed unanimously
- #3 Eliminate one person per club on E-Board clause passed unanimously
- #4 Adding Convention Co-Chair position passed unanimously
- #5 Expanding definition of Director of Charities passed unanimously
- #6 Expanding time frame for conventions to be held passed unanimously
- #7 Establishing R/E committee as filter for bylaws 14 fore, 1 abstention

2017 bylaws to review – elimination of Distribution Manager since it will go to VP of Membership

Need to look at Blue Bars, printed version, and seek alternate suppliers and methods of shipping as a cost saving measure
