All events to be held at the Mineral Wells Airport (Heliport), in Mineral Wells, TX. Lunch meal ticket will be provided both days, with your registration package.

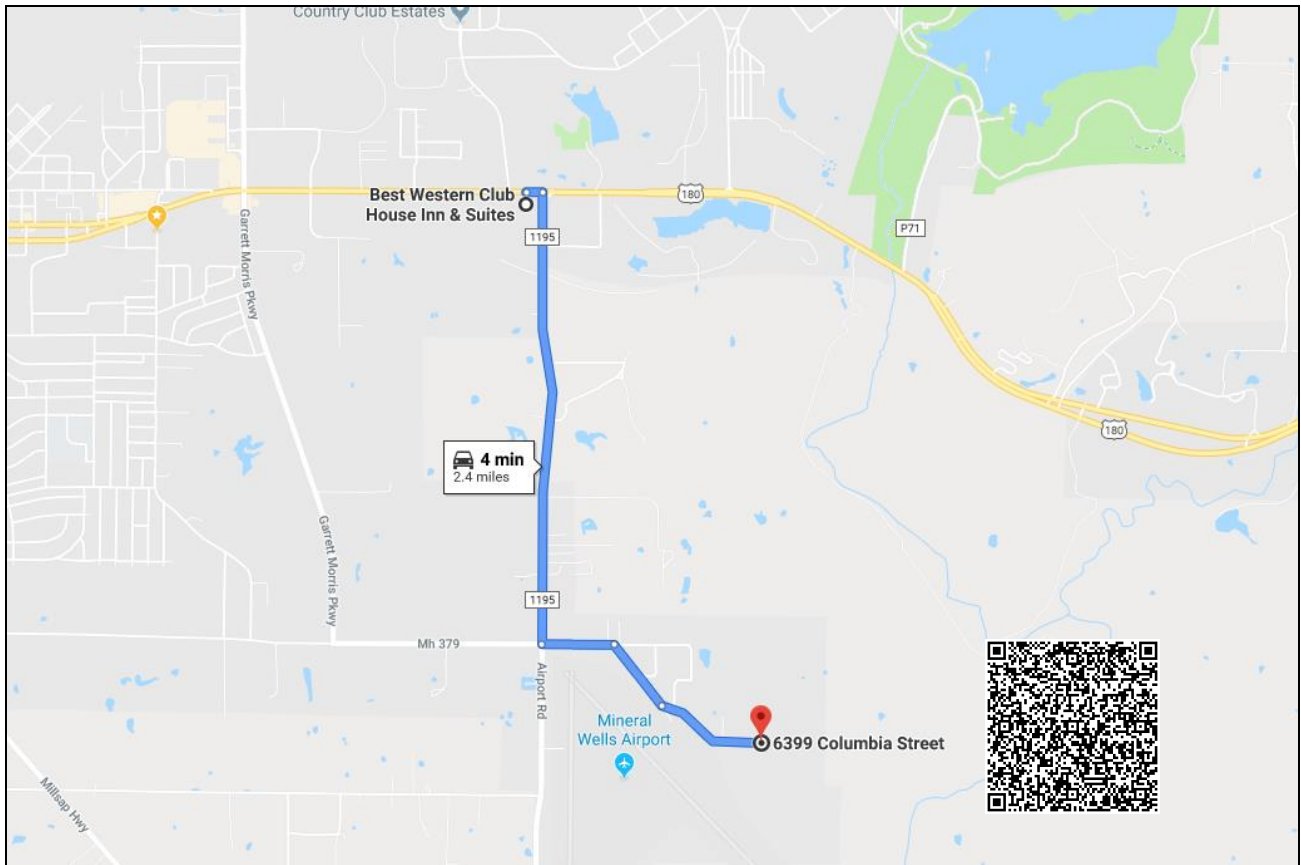
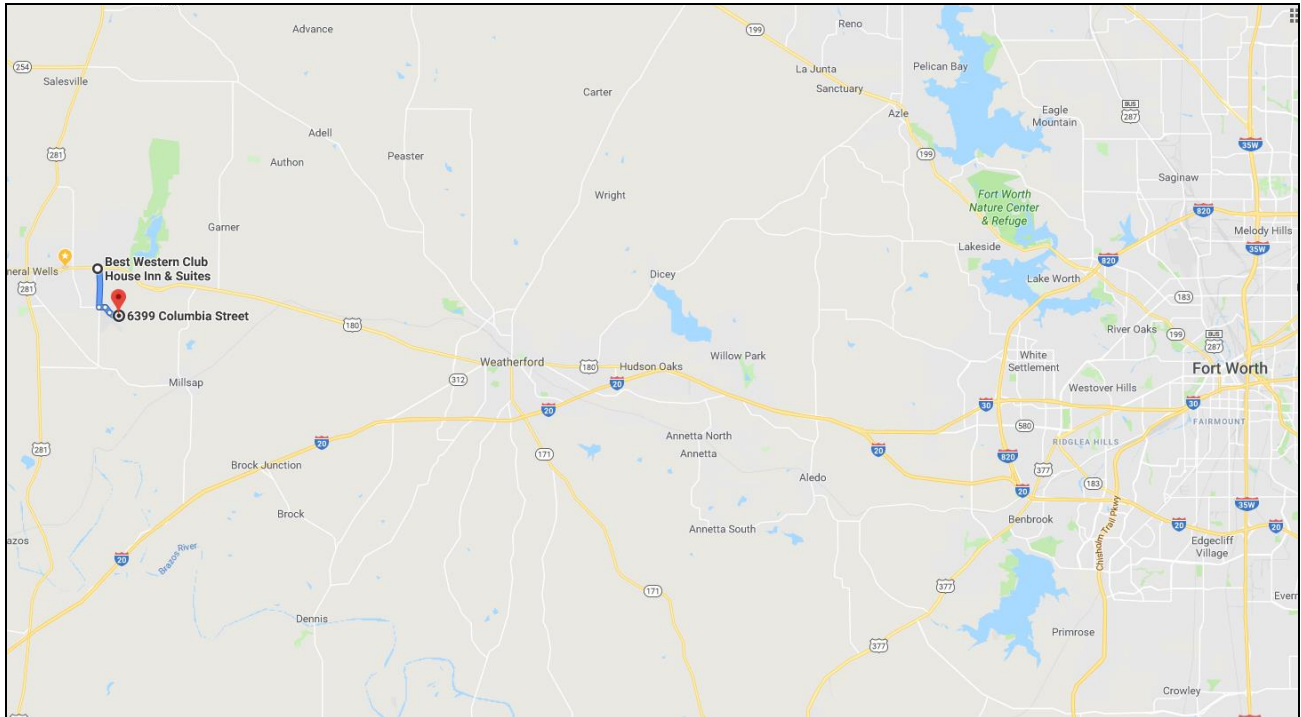
