



RETURN TO THE DOGWOOD TRAILS

HOSTED BY TEJAS VETTES
MARCH 21st & 22nd, 2020



All are invited to join with Tejas Vettes for an eventful weekend of events, "Return to the Dogwood Trails", taking place during the weekend of March 21st and 22nd, 2020 at Palestine, Texas. The events kick off early Saturday morning, March 21st by joining in a city sponsored parade that commemorates the first weekend for the city of Palestine's annual "Dogwood Trails Festival". The festival takes place three consecutive weekends each year and you are encouraged to partake in other city festivities beyond those being offered by Tejas Vettes this weekend. Event Driving Directions: The city of Palestine is often stated to be pretty much located equidistant from Shreveport Louisiana, Houston & Dallas, Texas. Of course, this is a relative term of distance for Texans and not known to be exact. To simplify directions, actual location for the Parade, Funkhana and both Rallyes are referenced from our host hotel for this weekend, the Holiday Inn Express.

With exception of the Saturday night cookout and get-together at the host hotel, the city Parade, Funkhana, Hayride and both Rallyes either take place or initiate outside the South side of the Anderson County Courthouse, around 614 East Crawford Street; Palestine, Texas 75801. (The actual address for the courthouse is on the West side and on a state highway that can't be blocked off for our events). Departing the host hotel, take a left out of the hotel, heading West on East Palestine Street for ½ mile to North Mallard Street (TX-19). Head South on N. Mallard St. for ½ mile and turn left onto East Crawford Street for approx. ½ block to the destination.

Host Hotel for this event: Holiday Inn Express; 1030 East Palestine Ave.: Palestine, Texas 75801

- The hotel is situated on the east side of Palestine, approximately ¼ mile *inside* "Loop 256". Those entrants that are staying at the host hotel should expect to find the hotel just past "All Star Chevrolet, GMC, Cadillac" when approaching from "Loop 256". For convenience and ease of directions, it is suggested that attendees use "Loop 256" to access the host hotel.
- A block of 30 rooms (15-king / 15-double queen) has been set aside for those early entrants at a base rate of \$95 per night. Be prepared if questioned regarding your entry status. The block & reduced rate will expire on March 12th. To make your early reservation, call Joni Mitchell @ (903) 723-4884.

Alternate Hotel for this event: Comfort Suites; 301 Willow Creek; Palestine, Texas 75801

- Approaching from the West on U.S.-79 (dba. US-84) turn right to take South Texas "Loop 256" heading East for 1 ¼ miles to Willow Creek Pkwy. The hotel is on your left. From U.S. Hwy 287/TX Hwy 19, turn right to take South Texas "Loop 256" westward for 1 ¾ miles to Willow Creek Pkwy. Hotel is at the intersection.
- Although rooms are not blocked at this location, we have found this hotel to be a "top-notch" alternative.

Following the Parade on Saturday March 21st, a sanctioned "People's Choice Car Show" is to take place in the afternoon, followed by a sanctioned Funkhana. As the Funkhana winds down, a "Hayride" is planned for those entrants of other events that wish to relax a little. Weather permitting: an outdoors' get-together & cookout will be taking place at the host hotel: hotdogs, hamburgers and light refreshments will be made available. While not mandatory, please consider dropping \$5.00 into the collection box to assist with the eats and drinks. ***Bring your own personal folding camp / tailgating chair as removing from the guest rooms is not preferred.

Sunday morning, March 22nd will consist of two events: a "Gimmick Rallye" and a "Poker (Chance) Rallye". These Rallyes will be running simultaneously to allow additional time for the entrants to get an early start on their return trip(s) back home.

Parade: Saturday March 21st – Non-sanctioned per NCCC guidelines: SW-163-N01 // *Chairperson: Alan Wach*

Initial discussion during the event planning is to meet outside the Anderson County Courthouse around 8:30 AM to receive our allotted time and position in the parade. Parade has an estimated start time of 10:00 AM. The actual time and exact location may differ slightly as the date grows near so please review the on-line event flyer for any updates.

***NOTE: Metal Cars (those entries that are not Corvettes) that wish to enter the Dogwood Parade should first contact the parade organizer. Otherwise, these entrants may consider joining with the corvettes but should expect to be grouped separately.

People's Choice Car Show: Saturday March 21st - Sanctioned event, SW-163-001 // *Chairperson: Eileen Fox;*

Due to the initial congestion around the parade, entrant check-in and tech will commence shortly after the parade has concluded and crowds have dispersed, at the south side of Anderson County Courthouse. Event will start at 12:30 PM, judging and completion at 2:30 PM. Car classifications: C1, C2, C3, C4, C5, C6, C7, Custom, RP, Metal

***NOTE: Metal Cars (those entries that are not Corvettes) that wish to show and be judged along with the Corvettes are welcome to do so. NCCC points will not be awarded unless the vehicle is a Corvette.

Funkhana: Saturday March 21st – Sanctioned event, SW-163-002

The driver's meeting for the Funkhana event will be take place on location at the south side of Anderson County Courthouse @ 2 PM (during the People's Choice Car Show), first car / team off at 2:30 PM and event completed by 5 PM or soon thereafter.

***NOTE: Metal Cars (those entries that are not Corvettes) may not enter this event, using that vehicle as the NCCC rulebook requires the use of a Corvette for this event. To enter this event, consider joining one of the Corvette teams as a navigator.

Hayride: Saturday March 21st - Non-sanctioned per NCCC guidelines: SW-163-R01 // *Chairperson: Laura Stracke*

Initial gathering for those that have entered sanctioned events and that wish to caravan to the hayride: will take place at the same general location as the previous two events: South side of Anderson County Courthouse.

Tech. at 8:00 AM for late entrants to be held at the South side of Anderson County Courthouse; followed with a Driver's meeting at the same location near the courthouse around 8:30 AM. This event is projected to begin around 9:00 AM and be completed by 12:30 PM. 3 ½ hour event time limit.

***NOTE: Metal Cars (those entries that are not Corvettes) that wish to enter the "Gimmick Rallye" are welcome to join in the fun as long as the requirements for age, license and vehicle safety are met, as covered in the NCCC Competition Manual / rulebook.

Poker (Chance) Rallye: Sunday March 22nd - Sanctioned event SW-163-004

Tech. at 8:00 AM for late entrants to be held at the South side of Anderson County Courthouse; followed with a Driver's meeting at the same location as the Gimmick Rallye near the courthouse around 8:30 AM. This event runs concurrently with the Gimmick Rallye event, also starting around 9:00 AM. Event completion may slightly exceed the 3 ½ hour event time limit of the associated Gimmick Rallye event. ***NOTE: With consideration for the entrants that wish to get back on the road for their return trip home, the Gimmick Rallye and Poker (Chance) Rallye are being run concurrently.

***NOTE: Metal Cars (those entries that are not Corvettes) that wish to enter the "Poker (Chance) Rallye" are welcome to join in the fun as long as the requirements for age, license and vehicle safety are met, as covered in the NCCC Competition Manual / rulebook.

Notes:

1. Tech. for sanctioned events may begin around 5 pm Friday March 20th at the host hotel as time permits.
2. Should the weather become severe, resulting with an event being cancelled for the weekend, the entrance fee for that event will be refunded by mail to the Driver's address listed on the NCCC database.
3. In order to keep entry fees at a minimum, trophies / t-shirts are not awarded for "Return ToThe Dogwood Trails" events.
4. All vehicles are to be operating with closed-exhaust during the weekend's events and display of speed is not permitted. Verify that required helmets and seat belts for the driver and navigator are as per latest NCCC Competition Rulebook. A printed copy of the 2020 – 2021 NCCC Competition Manual will be available for reference.
5. As these events are primarily to show support for the local community and merchants, lunch will not be included on either day. It is expected that there will be numerous vendors already in place to provide a wide variety of food options.

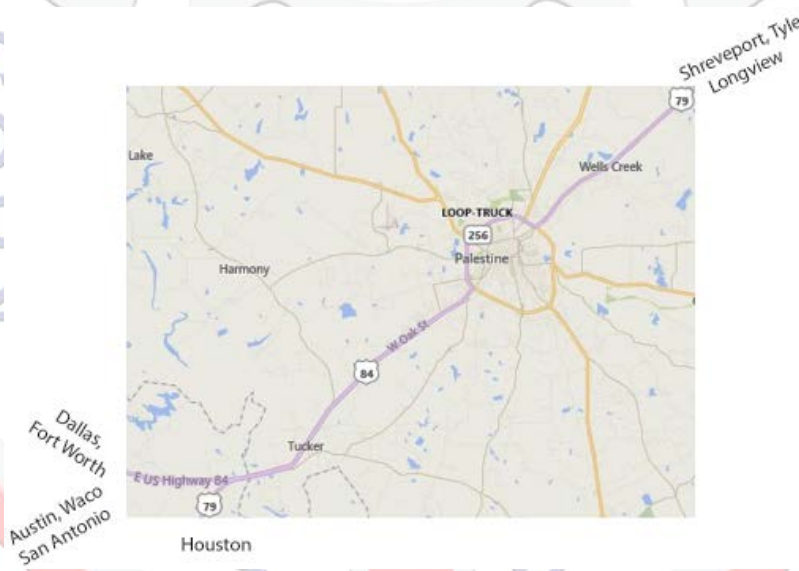
DETAILED DRIVING DIRECTIONS
(General information provided for the less experienced travelers)
MARCH 21st & 22nd, 2020



Arriving from the Northwest i.e.: Fort Worth or Dallas, Texas: Head south on U.S.-287. Depending on the location that you get onto U.S.-287, you may be departing Fort Worth (southwardly direction) and finding yourself passing through each of the thriving and growing communities of “Mansfield”, “Midlothian”, “Ennis” and “Waxahachie”. Once passing through “Ennis”, you will find yourself merging onto I-45 in a southward direction. Dallas travelers will also be leaving on I-45. Continue on the I-45 / U.S.-287 highway and take exit #198, turning east under highway and passing through the town of “Fairfield”. You will find yourself merging towards the east onto U.S.-84 and driving 9 to 11 miles until you reach “Loop 256” in Palestine. Head northward (left) on “Loop 256” and follow the loop around for 4.0 miles until you arrive on the east side of town, at a signal light & intersection for U.S.-79. Take a right onto U.S.-79, heading back into Palestine for approximately ¼ mile and you will find our host hotel, **Holiday Inn Express**.

Heading from Shreveport, Louisiana: Start out on I-20 west and follow U.S.-79 southward to cross “Loop 256” in Palestine and continue ¼ mile further. **Holiday Inn Express** will be on your left.

Driving from direction of Tyler / Longview, Texas: You will be coming in on Hwy 155, turning left onto “Loop 256”. Follow around ‘till you come to U.S.-79, turning right at the signal onto U.S.-79, driving about ¼ mile too locate the host hotel: **Holiday Inn Express**.



Originating your travels from the direction of Austin / San Antonio / Waco, Texas: You choose to use either U.S.-79 and U.S.-84 (or a combination of both) eastward to “Loop 256”. Arriving at “Loop 256”, turn northward (left) on “Loop 256” and follow the loop around clockwise for 4.0 miles until you arrive at a signal light & intersection for U.S.-79 on the east side of town. Make a right turn onto U.S.-79, heading westward back into Palestine for approximately ¼ mile where you will find our host hotel, **Holiday Inn Express**.

Driving from Houston, TX: Follow I-45 North for approx. 133 miles and take exit towards Buffalo, exit #178 / U.S.-79 east. Drive about 27 min. and merge on the right onto U.S.-84. Proceed approx. 1 mile to “Loop 256”. Head northward (left) on “Loop 256” and follow the loop around for 6.0 miles until you arrive on the east side of town, at a signal light & intersection for U.S.-79. Take a right onto U.S.-79, heading back into Palestine for approximately ¼ mile and you will find our host hotel, **Holiday Inn Express**. ***Check traffic reports as it may be quicker to take I-45 to State Hwy 19 North (at Huntsville) and follow it north to “Loop 256”.
