INFORMATION TO HELP YOU TO PREPARE YOUR CAR

The cars are judged in 4 categories for a possible total of 100 points. **Exterior Body** 30 points possible, **Engine Compartment** 30 points possible, **Interior** 25 points possible, **Undercarriage** (including, wheels, tires and exhaust) 15 points possible.

Points are awarded on quality of finish and detail in vehicle preparation. ***As judging begins have one door, the engine compartment, and deck lid opened, if not judges will deduct points.***

Judging begins (11:00 am).

Factors that contribute to point loss are: rock chips, paint flaws, wax residue, seat bolster wear, weather stripping wear, window streaks, disparity in body panel gaps, poor detail of hard to reach areas (door jams and hinges, wheels and wheel wells, under hood suspension areas, hoses, exhaust tips and hood liner). Each Class is judged by at least two judges and Class Award Winners will be determined by consensus of the judges.
