The Fastest Time of the Day (FTD) for Saturday will be announced at the Driver's meeting on Sunday.

LOCATION: Tarrant County College TCC - South Campus (5301 Campus Drive, Fort Worth, TX 76119)

Rigs & Cars may be left at the track both Friday and Saturday night (Parking Lot 1&2 South Flag Poles)

LODGING: Lodging: There is no host hotel. Several are in the area

EVENT DETAILS: (Low Speed Autocross)

- 7 autocross events on Saturday and 7 autocross events on Sunday.
- Safety tech, and on-site registration: will begin on Friday afternoon during track setup & Saturday and Sunday at 7:30 AM, on location.
- You must be present for the Driver's Meeting and Safety Tech to enter any of the events.
- **Drivers meeting 8:30 AM** First Car out after drivers meeting (2 parade laps then will start racing)
- Each Autocross (7 each day) will be 2 runs and will take the fastest time

RESTROOMS: are available on-site see maps for details

LUNCH: will be provided for workers, drivers, and additional purchased lunches.

- There will be no class changes after cars are teched unless the car breaks and the break is verified by tech.
- All entrants eighteen (18) years and older MUST also sign the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT and any other release documents which maybe required by NCCC.
- Entrants younger than eighteen (18) years old must have a parent or legal guardian present for the event and submit a properly completed PARENTAL CONSENT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT and a MINOR'S ASSUMPTION OF RISK ACKNOWLEDGMENT and any other release documents which may be required by NCCC.
- No person may compete who has pre-run through all or any part of the course, in any wheeled vehicle. Any competitor with a physical disability that impairs his/her ability to walk may, with the approval of the Chairman of the Event, use a wheelchair, bicycle, scooter, or similar aid traveling at normal walking speed can be allowed.
- No EV's allowed at this event with the exception of the Corvette E-Ray.
