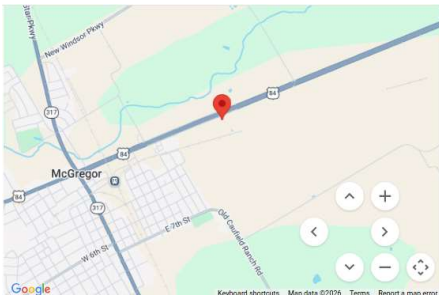
Notes:
